Player Agreement

- I. I, the undersigned, wish to participate in events run by Triumph. I recognize and understand that playing Triumph involves running certain risks. Those risks include, but are not limited to, the risk of injury resulting from the use of boffer weapons and injuries resulting from tripping or falling over terrain in the game playing area. In addition, I recognize that the exertion of playing Triumph could result in injury or even death.
- II. Despite these and other risks, and fully understanding such risks, I wish to play Triumph and hereby assume the risks of playing Triumph. I also hereby hold harmless the event organizers and the locations where Triumph is being played, and indemnify them against any and all claims, actions, suits, procedures, costs, expenses (including attorney's fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing Triumph. I hereby release the event organizers and site owners from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the event organizers and site owners that I am in good health and do not suffer from a heart condition or other ailment which could be exacerbated by the exertion involved in playing Triumph. I further certify that I am 16 years of age or older and that falsification of this document will result in immediate expulsion from Triumph with no refund.
- III. I hereby promise to play Triumph only in accordance with the rules of Triumph as set forth by the event organizers and site owners. In particular, I agree:
 - (a) to avoid physical contact or fighting with other players; (b) to stay within the boundaries of the playing area and not to chase or run after anyone over ledges or dangerous terrain; (c) to avoid simulated fighting around open flames such as a firepit or tiki torch; (d) to avoid running after dark.
- IV. I agree to ask the event organizers for clarification of any rule or safety procedure, for further instruction with regards to anything I do not understand about the equipment and supplies, or with regards to anything else that may affect the safety of, or playing of, Triumph.
- V. I agree to allow Triumph to use any photographs taken of me at Triumph for use on the Triumph website. I understand that if I request, in writing, the removal of any photographs of myself from the Triumph website it will be done within sixty (60) days.
- VI. I agree not to use alcohol or illegal drugs at Triumph, nor will I bring alcohol or illegal drugs into the game playing area. I will not leave the site during Triumph to use alcohol or illegal drugs, and if I do, I agree not to return to the game. If suspected of being under the influence of illegal drugs or alcohol during an event, I understand that I will be asked to leave immediately and without refund. I understand that should I be asked to leave due to alcohol or illegal drugs, I will also be permanently banned from participation in Triumph.

I have read this waiver of liability and assumption of risk carefully, and understand that by signing below I am agreeing, on behalf of myself, my estate, my heirs, representatives, and assigns not to sue the event organizers or site owners, or to hold these parties or their insurers liable for any injury, including death, resulting from my playing Triumph. I intend to be fully bound by this agreement.
